U.S. CPA Requirements (Each State/Jurisdiction is Different)

Education

Obtain 120 or 150 semester hours, out of which a specific number of accounting and business credits, for exam/licensure (Foreign academic evaluation is required for non-U.S. graduates).

Uniform CPA Examination

Pass four computer based tests (i.e. Financial Accounting and Reporting, Auditing and Attestation, Regulation, Business Environment and Concepts).

Experience

Gain 12 months or more related work experience (non-U.S. experience accepted).

IQEX Exam Overview

The International Qualification Examination (IQEX) is set by the AICPA and administered by NASBA, and allows qualifying internationally trained accountants to bypass the U.S. CPA Exam and attain the U.S. CPA credential through reciprocity. The exam is designed to award the U.S. CPA license to internationally trained accountants from countries whose professional bodies have entered into a mutual recognition agreement (MRA) with AICPA and NASBA. In 2018 AICPA and NASBA entered MRA with Irish and Scottish Institute of Chartered Accountants.

The exam covers ethics, professional and legal responsibilities, business law, and taxation related specifically to U.S. accounting practices. The format of the exam reflects the Regulation portion of the U.S. CPA Exam.
